### **Mayor Report and Comments**

- A. Cresson Spring Clean Up-Waste Connections provided 3 trucks and there was a steady flow of people bringing items. Thanks to Waste Connections and the Cresson United Methodist Church
- B. Emergency road repair on Skyline Drive-The road and bridge that were washed out have been repaired
- C. Emergency clean out of Bluebonnet Drive by Parker County-The low crossing culvert that was clogged due to the high rains has been cleaned out by the Parker County Commissioners office
- D. Great Race postponed until Father's Day 2021-We have received the refund check for our donation
- E. **Bluebonnet Hills water outage update-**The 2 water lines that were damaged by a private citizen have been repaired. Well 3 was drained due to a faulty sprinkler valve. Thanks to Victor for his hard work on the repair and to Rachel, and Katy for fielding phone calls
- F. Update on Cresson Bypass/Relief Route-Closure of 171 is postponed due to equipment problem, no new dates at this time
