- C. Update on turn lanes for Skyline and Bluebonnet off Hwy 377-TXDOT has added the two turn lanes into the Bluebonnet Hills subdivision. Mayor Conway has also spoken with TXDOT about other areas on Hwy 377.
- D. **Bluebonnet Hills tree trimming-**The trees have been trimmed on Brook Drive to provide clearance for the firetrucks.
