- A. **Update on Sales Tax trend**-The sales tax went down in August from \$80,000 to \$57,000.
- B. **Update on S. Crook Street**-Express Paving should be working on the repaving project in the next week. Both the owner of Express Paving, Don Humphries and his wife have been in the hospital.
- C. **Juanita St and CR 917/Lancaster potholes**-The street has been repaved and the large potholes have been filled.
- D. **Cresson Fall Festival**-The Fall Festival will be held on Saturday, October 24, 2020 from 9AM to 2PM with a modified format. There will be no live auction, but will still have the silent auction, cake walk, bake sale, Halloween costume contest, and the BBQ lunch.
