**B. Consider, discuss, and/or take action on City Ordinance No. 2018-001, the City Administrator Ordinance**

Councilperson Becker makes a motion to amend the above ordinance as written with the corrections to the section number and to read "up to 20% of the City Administrator's annual gross salary" in Section 4. Upon motion duly made by Councilperson Becker and seconded by Councilperson Clement. 5 ayes and 0 nays. The motion passed unanimously.

**C. Consider, discuss, and/or take action on the review of the City Administrator**

Councilperson Becker makes a motion to accept Resolution 2020-003 as written and set the consideration amount at 10% of the City Administrator's gross annual salary. Upon motion duly made by Councilperson Becker and seconded by Councilperson Manley. 5 ayes and 0 nays. The motion passed unanimously.
