Citizen's Comments

Tony Jones of 416 Thistle Court has questions regarding a map that was put in his mailbox regarding a development.

Lana Mazzo of 8200 Scenic Ridge Court wanted to make the council aware that the fire hydrants in Scenic Ridge do not work. She wonders if there are more homes build how will fires be put out.

Mayor Report and Comments

- A. Relief Route update-The Old Granbury Road crossover will be completely shut down temporarily while they prepare to pave between the concrete barriers to allow for transfer of traffic when needed. See more information on the website.
- **B.** Building and Standards Commission training date-The tentative training date, which will be led by Andrea Russell from the TOASE firm, has been tentatively set for May 17 at 7 p.m. in the city hall chambers. Council needs to be thinking of a replacement name for the alternate list for Brenda Johnson who is unable to serve. This will be on the next agenda for council.
- C. Cresson Spring Cleanup date April 23, 2022, with a rain date of April 30-Spring Clean Up is for trash customers. A flyer will be sent with bills.
- **D.** Possible new businesses showing interest in Cresson-Folks that have reached out regarding new businesses in Cresson include a restaurant where Rooster's was and a husband/wife team who are primary care physicians at JPS who are considering starting a practice in Cresson.
- E. Additional Developments-True Grit, LGI, MSR, Vorhees and Bourland Fields continued planned growth—True Grit developers are looking at a development like Putteet Hill and Highland Estates. One that is very close to getting started is LGI Homes on Land Fund's property on Old Granbury Road which will not only have homes by a retail strip which will bring the options of amenities for our city. Jark Farr's MSR is very near bringing to council their plans for an overlay district which will also add density to his current MSR. The property on Godley Hwy near CR 1000, owned by Ryan Vorhees will also add homes to our community. It resides in our ETJ, and his plans are to have any kiddos to attend Granbury ISD. Bourland Fields will soon be adding approximately 15 additional homes.
- **F. February Sales Tax-**Sales tax for February trended down from last month for a total of \$88,000.
