Cresson City Council Meeting November 8, 2022

Mayor Conway called the City Council Meeting of Cresson, Texas to order at 7:00 P.M. on November 8, 2022, at the City Council Chambers. Attendance as follows:

Citizen's Comments

Beverly Farren of 138 Brook Drive spoke regarding a person living in a trailer on someone's property and they were dumping sewage into the street on Columbus Day. City Hall was closed that day. She said that there is another address that the people are living in their garage and a third address that someone is living in a bus. She states something needs to be done because the way the economy is going it will continue to get worse.

Mark Markovich of 124 E. Bluebonnet Drive said he had 8 chickens killed the previous night. He is not sure if it was the dog at 121 E. Bluebonnet Drive, but they have been having problems with the dog that lives at that address. He states the homeowner lets his dog run loose in the road and onto other people's properties. He states they and other neighbors have called Parker County sheriff multiple times and nothing has been done. He wonders what the city can do about it.

Deanna Clark of 200 E. Bluebonnet Drive spoke again regarding the "dilapidated mobile home" across the street from her property. She says there are so many ways it is illegal, and the city needs to make him move it. She also believes this neighbor is parking illegally. She thinks there needs to be an ordinance change in the SF7 zoning to require large lots and questions why there is not a request for online for such a thing.

- C. An application received from Jack Farr for a change in zoning from General Commercial "GC" to MSR-GC, MSR-SF7, and MSR-TH for 276.2454-acre tract of land being part of the Nancy Smith Survey, Abstract 512 & 755, Hood County, Texas.

Councilperson Keeney seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.
- E. Approve the minutes from the city council meeting held on October 25, 2022-Councilperson Becker makes a motion to approve the minutes as written. Councilperson Robertson seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.
