

**Minutes of
Cresson City Council Meeting
April 25, 2023**

Mayor Conway called the City Council Meeting of Cresson, Texas to order at 7:00 P.M. on April 25, 2023, at the City Council Chambers. Attendance as follows:

Councilperson Becker gave the invocation and Councilperson Keeney led the U.S. Pledge and the Texas Pledge.

The meeting was opened to the public.

Citizen's Comments

Mayor's Report and Comments

A. Sales Tax Update: March Sales Tax is up, coming in at \$103,672.

B. Train continues to be an issue: The mayor had a call with a Senior Manager in charge of the Cresson Switching Station and was told so long as the train moves every 20 minutes that they are within the law.

C. Road repair in Cresson is underway: CR 918 has been partially patched as well as some places in Bluebonnet Hills. We are awaiting a bid for larger repairs that cannot be done by the city staff.

D. Feedback from Cresson Clean Up: There was a good turnout on 4/22/2023 for Cresson Cleanup. We filled 3 trucks with trash and a roll off with metal. The metal was then stolen over the weekend. We continue to partner with owners in town to take care of their properties.

Deliberation Agenda

A. An application received from Justin Howe for a change in zoning from rural Residential "RR" to Planned Development "PD" for a 1.440-acre tract of land in the B.B.B. & C. R.R. Company Survey, Abstract No. 159, Parker County, Texas.

1. Hold Public Hearing-The public hearing is opened at 7:05pm. There are no questions or comments from the public or the council. The public hearing is closed at 7:06pm.

2. Consider and take any action to approve or disapprove the change in zoning ordinance-Councilperson Becker made a motion to approve Ordinance 2023-001. Councilperson Robertson seconds the motion. 4 ayes and 0 nays. The motion passed unanimously.

B. Consider and take any action to approve or disapprove Resolution No. 2023-004 authorizing the city secretary to execute and submit Global Opioid Settlement documents relating to the Allergan, Walmart, CVS, Walgreens, Jassen, Distributors, Endo, and Teva settlements and any future opioid settlements negotiated by the State Attorney General; and adopting the Texas Term Sheet and providing for an effective date-Councilperson Keeney makes a motion to approve Resolution 2023-004. Councilperson Becker seconds the motion. 4 ayes and 0 nays. The motion passed unanimously.

C. Consider and take any action to approve or disapprove renewing the city's membership with TEX-2 for \$2500 for one more year-Councilperson Robertson makes a motion to approve the membership. Councilperson Clement seconds the motion. 4 ayes and 0 nays. The motion passed unanimously.

D. Approve the minutes from the city council meeting held on March 14, 2023-Councilperson Becker makes a motion to approve the minutes as written. Councilperson Keeney seconds the motion. 4 ayes and 0 nays. The motion passed unanimously.
