## **Mayor's Report and Comments**

- A. Sales Tax Update-April sales tax was \$103,155. It is still trending upward.
- **B.** Cresson Estates at CR 1000 Update-Ryan Vorhees told the city he has 325 lots ready to go, he hopes to start building model homes in June, and one of the builders will be DR Horton.
- C. Cresson Wrench Food Truck is open for business-the food truck owned by Bambi and Ronnie Bridges is open for business at 9501 Lancaster St. Please go out to support the local businesses!

### Nominate New City Councilperson Place 4

- A. Mayor's nomination for City Council Place 4-Bambi Bridges has resigned her position as Councilperson Place 4. Now that her food truck is open, she does not have time. Mayor Conway recommends Melanie Athey to replace her.
- **B.** Council vote to approve or disapprove the nomination-Councilperson Becker makes a motion to approve Melanie Athey to fill the remaining year of the Council Place 4 seat. Councilperson Keeney seconds the motion. 4 ayes and 0 nays. The motion is passed unanimously.
- **C. Swear in new councilperson, if approved by council-**City Secretary Katy Froyd swears in Melanie Athey and she takes her place on the dais.

**A. Appoint Mayor Pro Tem-**Councilperson Clement makes a motion to have Councilperson Becker remain as Mayor Pro Tem. Councilperson Robertson seconds the motion. 4 ayes, 0 nays, and 1 abstention (Councilperson Becker). The motion is passed unanimously.

- **B.** Consider and take action on a resolution canvassing the vote from the May 6, 2023, election-Councilperson Keeney makes a motion to approve Resolution 2023-005. Councilperson Athey seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.
- C. Consider and take action on the FY 2020-2021 audit as presented by Chris Turner at the May 9, 2023, City Council meeting- Councilperson Becker makes a motion to accept the audit as presented. Councilperson Clement seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.
- **D.** Approval of the minutes from the city council meetings held on 4/25/2023 and 5/9/2023-Councilperson Backer makes a motion to approve both minutes. Councilperson Keeney seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.
