Mayor's Report and Comments

A. Sales Tax Update-May sales tax was \$83,593. It trended down a bit last month. The mayor reminded the council that 1/3 of the sales tax monies must be dedicated for road maintenance.

A. Consider and possibly take action on a Petition for Voluntary ETJ Expansion for a 164.07-acre tract of land-Councilperson Becker makes a motion to approve Ordinance 2023-002 the Voluntary ETJ Expansion. Councilperson Clement seconds the motion. 5 ayes, 0 nays. The motion is passed unanimously.

B. Consider and possibly take action on a Final Plat application received from Bryson Adams for 378.25-acre tract of land-Mr. Chuck Stark of Barron and Stark Engineering is present to answer any council questions, Councilperson Becker makes a motion to approve the Final Plat for Cougar Mountain Estates. Councilperson Keeney seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.

C. Consider and possibly take action on a Replat application received from American Underwater Services, Inc. for a 0.265-acre tract of land-Mr. James Stevens of Texas Surveying is present to answer any council questions. Councilperson Becker makes a motion to approve the replat. Councilperson Robertson seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.

D. Consider and possibly take action on a Replat application received from Jeff Taylor, owner of a 0.207-acre tract of land-Mr. Jeff Taylor is present to answer any council questions. Councilperson Becker makes a motion to approve the replat. Councilperson Athey seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.

D. Approval of the minutes from the city council meeting held on 5/23/2023-Councilperson Robertson makes a motion to approve both minutes. Councilperson Keeney seconds the motion. 5 ayes and 0 nays. The motion is passed unanimously.
